St. John Evangelical Lutheran Church Annual Meeting Minutes January 22, 2017 10:00 AM

Opening Devotion-President Eric Johanningmeier

President Johanningmeier asked to amend the agenda to move the election of call committee to start of new business so that there would be time to tally votes during meeting. Motion to approve the agenda as amended by Jeremy Heyer, 2nd by Kurt Hoeft. Motion carried.

Minutes of 2016 Annual Meeting

Motion to approve the 2016 Annual Meeting minutes by Kurt Hoeft, 2nd by Judy Hughes. Motion carried.

Old Business

- 1. Board reports
- 2. Staff Members recognized.
- 3. Recognition of board members and those leaving.

New Business

1. Election of Call Committee

- a. Nomination ballots for call committee were handed out to the congregation. Pastor Odermann explained that we would like to have 9 people serve on the call committee. This is an expansion from our current constitution. Ballot consisted of 12 names. All twelve people will end up serving on the call committee, nine as regular call committee members and three as alternate members. Odermann instructed the congregation to vote for nine people on each ballot. The top nine people to receive votes will be the regular members the other three will be alternates. He also guided the congregation to consider a well-rounded call committee that would include youth and people that would represent the church population. Call committee will consist of the following people: Julie Begemann, Ana Blickenderfer, Kathy Crooks, Greig Grimm, Greg Heidebrink, Carter Johanningmeier, Becky Meyer, John Rima, and Shirley Ripley. Alternates for the call committee are Leonard Erickson, Nancy Scherer, and Janet Petefish. Motion to approve the call committee Josh Dean, 2nd by Shirley Holm. Motion carried.
- 2. Finance Board-Ministry Support Plan:
 - a. Presentation by Kathy Rogotzke. Kathy announced that the church ended the year with a positive balance of \$12,480. In figuring the budget for next the year the committee include an estimate for revenues. This is a change from the past. There were three major areas that have changed from last year. The first addition to the budget was an amount of \$10,000 to be used for technology needs. The next was to increase the funding to the preschool. Enrollment is down due to state sponsored program being offered. The third area was to increase church support for the youth and family ministries coordinator. This position for the last three years has been paid for in part by a private donation. The current year is the last year of that donation. Kathy also pointed out that finance also left an amount of \$20,000 in the budget for a part-time pastor. Finance felt that although this was an amount that was not used much this year, the money should be kept in the budget to meet future needs. Motion to approve the Ministry Support Plan by Cherie Schafer, 2nd by Kent Hoeft. Motion carried.
- 3. <u>Election officers and board members</u>- See ballot. Motion to approve nominations to the boards on the ballot was made by Sue Baron, 2nd by Dave Boehmer. Motion carried.

- 4. Presentation of Interim and Call Process-Pastor Odermann. Pastor Odermann recognized the transition team and thanked them for their service. Next step will be scheduling a meeting with the new call committee. A leadership retreat is being planned for February 3rd and 4th for the council leaders, interim pastor, staff members, call committee members and board chairs (or representatives). By the end of the retreat or shortly after the council will need to enter information gained from the retreat into the Ministry Site Profile and the have it approved. Call Committee will receive a final copy of Ministry Site Profile and begins interview design. Would like to have a town hall style meeting with congregation to let them know up front what kind of pastor we are searching for and what is expected of them in the first year. Call committee will then start down the interview process.
- 5. Discussion on the Parsonage- Pastor Odermann had contacted Pastor Brackett from the synod to see if he had any insight as to what to do with the parsonage. Pastor Brackett's advice to Pastor Odermann was to keep the parsonage. He said some of the issues that the candidates for your new pastor run into were that they have purchased a house in the community that they are coming from and have not sold it yet. Therefore, it is hard for them to purchase another house. Also, there sometimes is a lack of good available housing for the candidate to choose from. At some point the council and congregation must decide what to do with the parsonage.

Motion to adjourn by Dave Boehmer, 2nd by Marylou Wohlers. Motion carried.

Youth & Family Ministries Coordinator

2017 was a very busy and active year at St. John. Below are some of the things that have involved the children, youth, and families at St. John this year.

In January, I was able to attend the ELCA Youth Extravaganza in Louisville, Kentucky and attend some great workshops and trainings.

In February, the 5th Grade took First Communion on Ash Wednesday, the Family Board sponsored a family Lent Event attended by almost 60 people, we celebrated the Driver's License milestone with those receiving their licenses in the last year, and a great group of youth and adults attended a Waterloo Blackhawks game.

In April, the Family Board sponsored an Easter Egg Hunt attended by 40 children and their parents on Easter weekend, and the St. John Youth held the annual Easter Breakfast, feeding about 200 people. We also "brought back" the Mother-Daughter Luncheon and had 125 ladies attend this fun teaparty themed event.

In May, we celebrated with 12 St. John members who graduated from High School.

June was spent in planning mode. We planned our mission trip, the RAGBRAI supper fundraiser and VBS. Also, four St. John Youth attended WIYLDE, and the youth planning to go to Kentucky on the summer mission trip baked pies and held two bake sales as fundraisers to help offset their costs.

In July 19 youth and five adults took a rented bus on a mission trip to Kentucky from the 5th - 9th. We had a lot of fun, and accomplished a lot of work, despite some rainy weather, and I feel so blessed to be a part of a group of people who continually make the best out of the situation even when it keeps changing! And with the cooperation of the Stewardship Board, we held a fundraiser supper during RAGBRAI's visit to Charles City.

August started out with the excitement of Pastor Russ' arrival and the beginning of his call here at St. John. At about the same time, we had 60 youngsters attending VBS and coming to a "Mighty Fortress" to learn about God's Word.

In September, we kicked off the school-year schedule with Rally Sunday. During worship we celebrated the Blessing of the Backpacks Milestone, and afterwards, the Family Board made a delicious meal, and Parish Ed hosted some fun games in the parking lot. We held the First Step Milestone for three-year-old entering Sunday School and the Entering Confirmation Milestone for 7th Graders entering our Confirmation program. We started up our confirmation program, Sunday School, and the After-School Program. What a month!

In October, we held our first "Confirmation Fair" and invited the congregation to come and view the "Faith Tri-Folds" each of our confirmands created. Then, we celebrated the Affirmation of Baptism with 14 students who completed the St. John Confirmation Program. Later in the month, the St. John bus took our confirmation students to Waterloo to participate in a Feed My Starving Children Mobile Pack event. We handed out Bibles to 1st and 4th Grade students just before Reformation Sunday.

November is Food Month for St. John Sunday School students. Eighty non-perishable food items were collected and donated to the food pantry.

In December, the Family Board hosted a 25 Cent Gift Store for kids to shop at and it was a great success. Then, three days later, they held the Family Advent Event where kids and parents worked together on wooden Advent candle wreaths and some other fun crafts. On a beautiful evening, some St. John members rode on, and walked alongside, the parade float. The Parish Ed Board coordinated and directed a really nice Sunday School Christmas Program with our PreK - 7th grade students acting out the story of Christ's birth and the Youth hosted a Soup Dinner that fed 135 people following the program.

The Youth, Family, and Parish Education Boards and the children, youth and families of St. John had a great year in 2017. And I would like to thank everyone who contributed to the success of, and participated in, all these wonderful activities. We look forward to another fantastic year in 2018.

St. John Christian Preschool 2017 Annual Report

Praise God from whom all blessings flow! It is a privilege to be part of the development of not only our little ones' academic and social skills, but also their spiritual growth. It is so exciting to see their eyes light up when they listen to God's word or to see a smile stretch upon their faces when they are singing and dancing to our praise music. We continue to receive blessing upon blessing to enrich and grow our preschool center!



Our 2016-2017 school year ended with an enrollment of 43 friends and we were excited to welcome many friends and families back for our 2017-2018 school year. With the addition of a few new faces we were able to start our school year with an enrollment of 52 friends who were anxious to see what a new year at St. John Christian Preschool would hold for them. Unfortunately, due to some families moving out of the area, we did lose a friend during the first semester. As we begin 2018,

we saw an increase in enrollment of up to 55 little ones! As always, we know that we will continue to be blessed with many families who are seeking a Christian education for their little ones and we expect to fill any openings quickly. It is a very humbling gift to know that we are being trusted with such an enormous job, but it is rewarding beyond words.

This year, we offered four NEW classes from which our families could choose. Our older friends who turned at least 4 by September 15 could enroll in either the three-day, Monday-Wednesday-Friday program or the 5-Day program. These classes were only offered in the afternoon, which met from 12:30-3:30pm. Our younger friends who turned at least 3 by September 15 could enroll in our two-day program, Tuesday-Thursday, or our three-day program, Monday-Wednesday-Friday. These classes were only offered in the morning, which met from 8:30-11:30 a.m.

Our registration fee remained the same at \$25 per semester or a one-time fee of \$40 for the year. Our two-day tuition was \$80, and the three-day tuition was \$95. Both 3-Year-Old class options are three hours. Our 3-day afternoon tuition remained the same at \$95 and the 5-Day tuition was \$170. Our preschool board offered a tuition reduction fundraiser each semester, which provided opportunities for families who participated in the fundraiser to earn profits to lower their child's tuition payments. Each semester about 15-20 families participated and their tuition accounts were reduced accordingly.

We were continued to be blessed with grant money from Floyd-Mitchell-Chickasaw Early Childhood Iowa (ECI) scholarship program, which is an amazing form of assistance for almost half of our preschool families. ECI scholarships are available for families displaying a financial need for help with tuition.

This year we were able to offer 2 scholarships in Cindy Zirbel's memory. These scholarships were not based on financial need, but rather awarded to families who wrote a short letter explaining why they chose SJCP. Families enrolled in our 4/5-year-old programs that were not eligible for ECI funds were encouraged to apply. The scholarships were offered to one family in each of the classes. One in the amount of \$40 a month for each of the eight months in the school year. One in the amount of \$70 a month for each of the eight months in the school year. This year, however, we only had one family apply. The family who received this scholarship had a child enrolled in the 5-day program, so they were awarded the \$70/month for eight months. This family was a very appreciative recipient and we were pleased to be able to offer this scholarship to this well-deserving family.

We also have the "Friendship Scholarship" for our younger, 3/4-year-old programs. Families enrolled in these programs that were not eligible for ECI funds were encouraged to apply. The scholarship was in the amount of \$35 a month for each of the eight months in the school year for the 2-day class and \$40 a month for each of the eight months in the school year for the 3-day class. Unfortunately, no applications were sent in for this scholarship.

The Preschool staff and board members would like to remind everyone that Kwik Star gift cards are always available for purchase at the Preschool. Since you need to purchase gas anyway, why not help our ministry all at the same time? Feel free to stop by and purchase at your own convenience. Please stop by or call the preschool at 228-7274 if you are interested in purchasing a gift card. Let us know if you have any questions, and as always, thank you for your support!

We are very blessed with an amazingly awesome staff: Whittney Franke, Director and Carleen Laue, Assistant Teacher/Onsite Supervisor. We are also supported by an amazing back-up team that includes our Foster Grandma, Evelyn Schmidt; as well as our dedicated Pastor Leeper; faithful office secretary, Kathy; highly efficient business manager, Linda; and a great custodial staff, John and Julie. Without their hard work, we would not be able to accomplish the things that we do.

The job of educating our youngest learners is most definitely not an easy one. Every day is different, full of obstacles, challenges and even frustrations, but there isn't a day that goes by when we are not reminded of the power of our mighty God. As any of our little ones would tell you...**OUR GOD IS AWESOME**, and it will be our honor to continue doing His work in the New Year.

2016 President's Report

What an unbelievably busy and blessed year for St. John! The entire congregation has continually been stepping up and taking on larger leadership roles, partnering with the Staff, ensuring that God's work continues to progress in Charles City. What a blessing to be a part of a growing and exciting ministry!

With so much activity in 2017, it is not possible for me to effectively report on everything, nor do I want to double up on the various board reports. Continuing from 2016, the transition team continued their work into the new year. Some continued with the Call Committee and combined with the Staff, Council, and board chairs, a retreat was held in February to help solidify the Ministry Site Profile. The retreat was immensely important for the leadership to understand where St. John is and where we want to go. With that important two-day event complete, finishing touches were made to the Profile and the call process for a new senior pastor could begin.

The call committee started in earnest with great anticipation of good things to come. While as President, I was not directly involved with the call process, but was kept in the loop as to what was happening with the committee. I recall vividly after initial interviews were scheduled and not long afterwards, I had a few members either call or stop by my office super excited with a candidate! In relatively short order, we were welcoming Pastor Russ and Susan Leeper to the congregation!

I appreciate the patience that the congregation provided while we worked through the call process. I know that there was frustration that the Profile and call process were taking so long, but it was important that it was completed as thoroughly as possible. Improving security of the facility, expanding the sound and video capabilities in the sanctuary, and possibly adjusting our worship and youth/adult education time. 2017 Finance Board Annual Report

Dear Family in Christ,

I am very thankful for our church family, and appreciate how we work and grow together helping support St. John's mission: "God's Love in Action". This year, 2017, was another year of change for our church—after so many years with very little change in staff we experienced change for the second year in a row with a new business manager and a new pastor. As always, I was reminded and comforted by the following verse from Philippians 4:19



"And my God will meet all your needs according to his glorious riches in Christ Jesus."

It has been a pleasure and honor to work with the finance board this year. We have a very dedicated group and I appreciate the time, prayer and thought that they generously give. The responsibilities of the finance board include:

a. Develop the annual budget. **b.** Review and approve expenditures. **c.** Monitor and adjust budget expenses if necessary. **d.** Monitor and decide which investment strategies would best serve the St. John congregation.

Highlights of the year/things we worked on:

"In everything I did, I showed you that by this kind of hard work we must help the weak, remembering the words the Lord Jesus said: "It is more blessed to given than to receive."" Acts 20:35

- ✓ Welcomed a new business manager, Linda Hughes, who brings experience as assistant to business manager and former finance board member.
- ✓ Continue to work on the process of transitioning our church's financial information to accounting software. The church uses Shephard's Staff which is an accounting software specifically designed for churches. It is a great tool that we believe will help us make more data driven decisions in managing the church's finances. Linda is working on learning more about all the features and reports.
- ✓ Had an outside agreed upon procedures report done by accounting firm in Mason City. They provided us with some very helpful suggestions that we are working on incorporating. Many of the suggestions are focused on increasing internal controls and documentation.
- ✓ Worked on incorporating financial best practices by updating signatures on bank accounts, maintaining schedule of CD renewals, organizing accounts and funds, documenting designated funds.
- ✓ Some of the larger expenses that were approved for this year by the board included:
 - Pastor call and moving expenses
 - O Bus fuel tank repair and A/C replaced (as recommended by the Building and Grounds)
 Parsonage updates (flooring update, garbage disposal, refrigerator replaced) (as recommended by the Building and Grounds)
 - Church Roof repair (as recommended by the Building and Grounds)
 - o Replacement of church kitchen floor
 - o Purchase of Clavinova (using memorial funds)
- ✓ Managed benevolence (1% to Youth, 1% to Community Ministries, 8% of regular offering to NE Iowa Synod and 8% of thank offering to: Crisis Intervention, North Lights Men's Homeless Shelter, EPIC Scholarship funds, Compassion, Food for the Poor, and Haiti mission trip).

Our current financial status:

- As of November 26, 2017, the total offering (including simply giving) received was \$381,131.79. This works out to an average weekly giving of \$7,940.25.
- ➤ Simply giving with regular monthly, weekly, or biweekly contributions continues to help make planning and budgeting easier. This year there are 68 members that participate in Simply Giving and contribute a weekly average of \$2,897.

Board of Deacons Annual Report of 2017

The Board of Deacons began the year of 2017 with six members. The two outgoing members who completed their three-year terms were June Kehret and Dan Lantz. Worship Service times continued to be held at 8:00 a.m. and 10:15 a.m. during the school year and 8:00 and 9:30 a.m. during the summer months. On seven Sundays only one worship service was held. They were: January 1, January 22 for the annual meeting, March 19 for the Call Committee meeting with Pastor Bracket, July 30 farewell reception for Pastor Odermann, August 20 to welcome Pastor Leeper, October 29 for the Fall Festival Reformation Sunday, and on Christmas Eve Sunday.

Communion was offered at two Sundays each month except for the first Sunday in August. An average of 128 were served at the early service and 106 at the late service. Before summer came to an end, we were able to hold our annual St. John Golf Outing on Wednesday, August 16th. We were excited to have Pastor Russ and Susan in attendance. We had a few downpours throughout the night; however, all of the golfers seemed to make the best of it. Kathy Crooks' potato salad helped put a smile on everyone's face. Several individuals and businesses donated through hole sponsorships or doors prizes. The funds we raised went directly to the Floyd County Cancer Fund. This year, we donated \$2,385.00 to the cancer fund.

St. John Angel Tree Ministry Report for 2016 Submitted by Jean Rima & Shirley Holm



In December 2016, the Angel Tree Ministry collected and distributed 40 gifts to 16 children of prisoners and their caregivers. Each child received two gifts and their caregiver received one gift. In addition to the donated gifts, each family received a ANGEL TREE Bible provided through cash donations from the St. John congregation. Bibles and

Christmas cards were sent to 7 prisoners. Two local families received Hy-Vee food vouchers which were provided by Angel Tree donations. Sue Baron donated Nativity sets, crayons, and activity booklets. The gifts and food vouchers were delivered to the local families. Gifts were shipped to the other five families. The prisoners and their families are especially appreciative for this ministry. When contacted, one mother said that we were the answer to her prayer.

THE NEEDY FUND – This ministry was started in 1986 in an attempt to offer assistance to individuals who found themselves needing assistance with energy bills. St. John was also trying to become more involved with community needs. This ministry receives 100% of its funding from our congregation and we have been very blessed with the generosity of our church members. Over the years, changes have been made to the structure of this fund and now primarily offers help to those needing gasoline and food.

The Needy Fund is currently in a state of transition. A call was put out to our congregation for volunteers to help with this fund and we now have a group of individuals who are willing to take time out of their busy schedules to assist from 10:00-11:00 on Tuesdays or Thursdays. This means that their commitment to this ministry is only for one day a week for one month two (maybe three) times a year.

In 2017, the Needy Fund helped 53 individuals. Food vouchers in the amount of \$840 and gas vouchers totaling \$610 were issued to these individuals. I am very proud to be part of this ministry and be able to see how God works through us to lighten the load of struggling people. I am thankful for the interest that has been expressed in helping this ministry. There is always room for more volunteers. 
