This will continue to be monitored. At this time offerings are not keeping up with expenses. Pastor Russ noted the air conditioner in the sanctuary has gone out so will need replaced. Preliminary estimate will be around \$10,000.00 so will need to look into where funds can be used to replace this item, possibility is the Disaster Relief Fund. Also, discussion was given as to the status of replacing the parking lot. Funds are not readily available so will consider what options the church would have to fund this much needed replacement. Also questioned was the parsonage roof has been repaired a couple times but still leaks. This will also need to be addressed in the future as a replacement or repair.
- 2. Council Report: None as there was not a representative present to report.
- 3. A name has been mentioned to replace Bruce Boerschel term for the Finance Board. Council will need to approve someone for this position.
