 - a. Presentation by Kathy Rogotzke. Kathy announced that the church ended the year on a positive balance. She thanked the congregation for their giving and also thanked the staff and board members for their work. She asked the congregation for any ideas on where they would like to see the 1% benevolence shared. She explained the process that is used to come up with the figures included in the Ministry Support Plan. A few areas were increased. Two areas that were included in the support plan were dollars for technology and additional help for Pastor Leeper. Pastor's Report 2018

17. That's the number of months it's been since you welcomed me as your pastor ... just seventeen months! I find that hard to believe because in these seventeen months I've met <u>so</u> many people and learned <u>so</u> much about St. John: our past, our people, and our procedures. Day by day I grow in my understanding of our strengths and our growth areas. So much information! It's been like a 17-month sip from a firehose! Accompanied by our dedicated and hard-working staff and our faithful, caring, and creative volunteers, we've accomplished much together in a very short time! I hope you'll read through the other reports in this document to get a fuller picture of all that we've done together in service to God and our neighbors over the past year. And despite the overwhelming flow of the last 17 months, I'm still thirsty ... thirsty to see what God has next for us, thirsty to get to know more people, thirsty to see how seeds planted by Pastor Niezwaag and others before me will continue to bear fruit, and thirsty to see what new seeds we can plant together.

Here are some of my Highlights of 2018 and Hopes for 2019, in no particular order:

Getting to Know You - Susan and I are very grateful for all of you who hosted and attended Meet & Greets this past year so that we could start to put names and stories with faces. We confess that we're still working on all of the names, but we know a lot more than we did 17 months ago! I'm excited that St. John is planning to do an updated pictorial directory in 2019. It will help us <u>all</u> get to know each other's names.

Confirmation - It was a little scary being thrown into a different confirmation program, having to adjust my teaching style, and re-write all of my lesson plans to fit St. John's structure. My classes are still a work in progress, but the great youth and caring adults that I get to do Confirmation with make all the time and effort worth it!

Children - So often I finish children's sermons and think, "I can't believe I get paid to do this." The playfulness of our children and the willingness of our congregation to participate in that playfulness makes children's sermons at St. John very fun ... and we're all learning together! So, keep bringing those kids and keep participating! It's also been a real joy for me to be at a church with a preschool. Going down to read the Bible story to the preschool kids on Wednesdays is always a highlight of my week.

Partnership with Messiah Lutheran - We're trying something new. This year the church council entered into a partnership with Messiah Lutheran Church to share a pastor. Messiah Lutheran Church called Rev. Norman Bauer as their 3/4-time interim pastor. St. John reimburses Messiah for 1/3 of Rev. Bauer's salary and benefits, so that he can spend a third of his time helping us with visitation, preaching, and funerals, while also serving the people of Messiah. It's an innovative approach to meet increasing financial challenges and the ever-growing clergy shortage. I'm proud to be part of this cutting-edge experiment and proud of our church council for seeing the value of giving it a try. I'm also extremely grateful for Rev. Bauer's partnership, as St. John is just too big for me to take care of by myself.

Generosity - It's vital to our spiritual health that we follow Jesus' teaching to be generous people. I was blown away by your generosity when we raised over \$6,000 in just a month for the Youth Mission Trips last summer! I've seen that same generosity come out in many other fundraisers, as well. I know that we have generous people at St. John. So, I hope that in 2019 we can talk more about our generosity to Christ's mission through St. John than we have in the last 17 months. If you take a look at the Finance Board report and Ministry Support Plan for 2019 you will see that there is no financial room for growth in our ministry. Even though we're keeping our expenses under budget, we're not covering them with our offerings. I dream of St. John being a place where we don't have to continually cut back our ministry, but where we can grow in new and exciting ways because we have the financial support to do it.

Sound & Video Project - Speaking of generosity ... It's been exciting to work with leaders at St. John to resurrect a plan that was first put in motion a few years ago to upgrade our sound and video system. I've had people say to me, "Now that you've come, we need to upgrade our technology." But it's actually the opposite. St. John had already decided they wanted to use more technology and then went looking for a pastor who would use it. That pastor turned out to be me. So, the technology upgrade isn't happening because I came. I came because you already wanted a technology upgrade. Amazing, isn't it, how God put that all together? Anyway, I hope that we will finally see that dream come true this year!

Stephen Ministry - Over the last 17 months I've had the opportunity to briefly accompany many of you through crises and difficult times. I consider that a great privilege and an important part of my calling. However, it won't be long before the next crisis arises and I will need to go accompany another family. My heart often aches for the grief and hurt that I know many in our congregation are going through. I wish I could sit down with them all to be a caring listener and a sign of Christ's love for them, but there just isn't enough time to do it. Fortunately, as Lutherans, we believe in something called "the priesthood of all believers." That means we're ALL priests, we ALL have the ability to be Christ to others. It's not just up to the pastor to walk with people in their difficulties, but we can do that for each other as well. Stephen Ministry is a one-to-one, confidential, caring ministry in which we train St. John members to provide Christian care to other members who are going through difficult times. Both Rev. Bauer and I have had experience with Stephen Ministry in other congregations and have seen the power of it on the lives of both care-receivers and care-givers. If you're a good listener and a caring person and have a couple of hours a week available to you, I hope that you'll sign up to be a Stephen Minister. I pray that we can get Stephen Ministry going at St. John in 2019. I can't do this by myself!

Well, if you've made it this far, thanks for hanging in there with me! As you can see, there are so many good things to talk about at St. John and so many exciting possibilities! Susan and I want to say thank you for all the kindness and love you show us year-round and for being our faith family here in Charles City. We thank God for you!!! And most of all, we give thanks for God's unconditional, life-changing love that comes to us through Jesus, our Savior. Without Him there'd be no annual reports, no annual meetings, no budgets because there'd be no Church. Thanks be to Jesus ... the reason we exist and the reason we keep moving forward.

Youth & Family Ministries Coordinator

2018 was a very busy and active year at St. John. Below are some of the things that have involved the children, youth, and families at St. John this year.

In January, the Youth Board was able to operate a concession stand for the Dartball tournament and that started out our fundraising for the middle school and high school mission trips.

In February, the 5th Grade class of 13 students took First Communion on Ash Wednesday, the Family Board sponsored a family Lent Event attended by over 60 people, and we celebrated the Driver's License milestone with those receiving their licenses in the last year.

In March, the Family Board held an EWOK event and sponsored an Easter Egg Hunt attended by 24 children and their parents on Easter weekend. The Youth Board started its "envelope" fundraiser for the trip in June to the ELCA Youth Gathering in Houston, Texas. The Youth Board also served almost 200 people at the Palm Sunday Breakfast, despite almost 14 inches of snow!

In April, the Youth Board organized a trip to Waterloo to watch the Black Hawks play hockey. The Family Board hosted a Ladies' Luncheon and had 80 ladies of all ages attend this fun Sea-Side Retreat themed event. And thanks to the incredible generosity of this congregation, we reached our fundraising goal by Easter!

In May, we wrapped up the After-School Program, Sunday School and confirmation classes. And we celebrated with ten St. John members who graduated from High School.

June was started in planning mode and ended in travelling mode. We planned our high school trip to the ELCA Youth Gathering and the middle school trip to Wisconsin and we planned VBS. Four St. John Youth attended WIYLDE. And Team St. John (11 members from here and Nashua combined) travelled to Houston, Texas, and back safely with many new experiences in between!

In July, ten middle school youth and four adults took a rented van on a mission trip to Prairie du Chien, Wisconsin, from the 5th-8th. We had a lot of fun, and accomplished a lot of work, despite some hot weather, and I feel so blessed to be a part of a group of people who continually make the best out of the situation even when it keeps changing!

August started out with VBS where we had 60 youngsters attending VBS and dealing with being "Shipwrecked." We learned that God is with us through ALL our struggles. The Parish Education Board did a fantastic job of organizing, decorating and hosting VBS again this year!

In September, we kicked off the school-year schedule with Rally Sunday. During worship we celebrated the Blessing of the Backpacks Milestone, and afterwards the Family Board made a delicious meal and Parish Ed hosted some fun games in the parking lot. We held the First Step Milestone for three-year-old children entering Sunday School and the Entering Confirmation Milestone for 7th Graders entering our Confirmation program. We started up our confirmation program and Sunday School. What a month!

In October, we started up the After-School program and we held our "Confirmation Fair" and invited the congregation to come and view the "Faith Tri-Folds" each of our confirmands created. Then we celebrated Affirmation of Baptism with 11 students who completed the St. John Confirmation Program. Later in the month, the St. John bus took our confirmation students to Waterloo to participate in a Feed My Starving Children Mobile Pack event. We handed out Bibles to 1st and 4th Grade students on Reformation Sunday.

November is Food Month for St. John Sunday School students. Eighty non-perishable food items were collected and donated to the food pantry. And the Youth Board hosted a Give Thanks Dinner to show our appreciation to the congregation for all the support throughout the year.

In December, the Family Board hosted a 25 Cent Gift Store for kids to shop at and it was a great success. Three days later, the board held the Family Advent Event where kids and parents worked together on some fun crafts. And on a beautiful evening, some St. John members rode on, and walked alongside, the parade float. The Parish Ed Board coordinated and directed a really nice Sunday School Christmas Program with our PreK-6th grade students reciting some Christmas poetry and acting out the story of Christ's birth. The Youth hosted a Soup Dinner that fed 100 people following the Program.

The Youth, Family, and Parish Education Boards and the children, youth and families of St. John had a great year in 2018. And I would like to thank everyone who contributed to the success of, and participated in, all these wonderful activities. We look forward to another fantastic year in 2019.

St. John Christian Preschool 2018 Annual Report



Another awesome year worshiping our AWESOME GOD! It is such a gift to be able to come to a job that is different and new every day. Each day comes with its own challenges and difficulties, but we also receive blessings upon blessings when we get to see our little ones grow physically, academically, socially and in their relationship with our Lord and Savior, Jesus.

Our 2017-2018 school year ended with an enrollment of 55 friends and we were excited to welcome many friends and families back for our 2018-2019 school year. With the addition of a few new faces we were able to start our school year with an enrollment of 45 friends who were anxious to see what a new year at St. John Christian Preschool would hold for them. As we begin 2019, we saw a slight decrease in our enrollment due to families moving out of the area. We now have an enrollment of 43 little ones. As always, we know that we will continue to be blessed with many families who are seeking a Christian education for their little ones and we expect to fill any openings quickly. It is a very humbling gift to know that we are being trusted with such an enormous job, but it is rewarding beyond words.

We continued to offer four classes from which our families could choose. Our older friends who turned at least 4 by September 15 could enroll in either the three-day, Monday-Wednesday-Friday program or the 5-Day program. These classes were only offered in the afternoon, which met from 12:30-3:30pm. Our younger friends who turned at least 3 by September 15 could enroll in our two-day program, Monday-Wednesday, or our three-day program, Monday-Wednesday-Friday. These classes were only offered in the morning, which met from 8:30-11:30 a.m.

Our registration fee remained the same at \$25 per semester or a one-time fee of \$40 for the year. Our two-day tuition was \$80 and the three-day tuition was \$95. Both 3-Year-Old class options are three hours. Our 3-day afternoon tuition remained the same at \$95 and the 5-Day tuition was \$170. Our preschool board offered a tuition reduction fundraiser each semester, which provided opportunities for families who participated in the fundraiser to earn profits to lower their child's tuition payments. Each semester about 10-15 families participated and their tuition accounts were reduced accordingly.

We were continued to be blessed with grant money from Floyd-Mitchell-Chickasaw Early Childhood Iowa (ECI) scholarship program, which is an amazing form of assistance for almost half of our preschool families. ECI scholarships are available for families displaying a financial need for help with tuition.

This year we were able to offer 2 scholarships in Cindy Zirbel's memory. Cindy and her husband, Jim, believed in, and set a high priority on the Christian preschool experience for their own children. This scholarship was awarded to a family with the same priority. These scholarships were not based on financial need, but rather awarded to families who wrote a short letter explaining why they chose SJCP. Families enrolled in our 4/5-year-old programs that were not eligible for ECI funds were encouraged to apply. The scholarships were offered to one family in each of the classes. One for the 3-day program in the amount of \$40 a month for each of the eight months in the school year. One for the 5-day program in the amount of \$70 a month for each of the eight months in the school year. This year, we only had one family apply from each class. These two families were very appreciative recipients and we were pleased to be able to offer this scholarship to these well-deserving families.

We also have the "Friendship Scholarship" for our younger, 3/4-year-old programs. Families enrolled in these programs that were not eligible for ECI funds were encouraged to apply. This scholarship was awarded to families who hope to not only establish a strong educational foundation for their little one, but also hope to raise their child to be a kind and gentle friend who will one day give back to his or her community. They applied for this scholarship by writing a short letter explaining how they thought their child's preschool experience would impact the person they later become. The scholarship was in the amount of \$40 a month for each of the eight months in the school year for the 2-day class and \$45 a month for each of the eight months in the school year for the 3-day class. This year, we had two families apply, but one family had already qualified for ECI, so the other family was awarded the scholarship. This family had a child in the three-day, 3-year-old class. This family was a very appreciative recipient and we were pleased to be able to offer this scholarship to this well-deserving family.

The Preschool staff and board members would like to remind everyone that Kwik Star gift cards are always available for purchase at the Preschool. Since you need to purchase gas anyway, why not help out our ministry all at the same time? Feel free to stop by and purchase at your own convenience. Please stop by or call the preschool at 228-7274 if you are interested in purchasing a gift card. Let us know if you have any questions, and as always, thank you for your support!

We are very blessed with an amazingly awesome staff: Whittney Franke, Director/Lead Teacher and Carleen Laue, Assistant Teacher/Onsite Supervisor. We are also supported by an amazing back-up team that includes our Foster Grandma, Evelyn Schmidt; as well as our dedicated Pastor Russ; faithful office secretary, Kathy; highly efficient business manager, Linda; and a great custodial staff, John and Julie. Without their hard work, we would not be able to accomplish the things that we do.

The job of educating our youngest learners is most definitely not an easy one. Every day is different, full of obstacles, challenges and even frustrations, but there isn't a day that goes by when we are not reminded of the power of our mighty God. As any of our little ones would tell you...OUR GOD IS AWESOME and it will be our honor to continue doing His work in the New Year.

From the President:

Here we are in January 2019 and my time serving as President is drawing to a close. I look back over the past few years and am amazed with the amount of change that St. John has experienced, the growth in the Congregation, and how bright the future appears. Let's recap a little of what the Council focused on this past year.

A significant cleansing project was undertaken with sorting through all of the church records; saving and maintaining any historical documents, but then disposing of unnecessary papers that had built up over decades. It was just simply time to sort through it all and lighten our load. We now have a solid process of first in/first out for rotating our documents that we need to keep. During the process of digging in closets, historical stain glass was discovered and that spawned another project that has yet to wrap up.

The Council also worked on forming a Personnel Committee, which focused on updating and documenting job descriptions with the help of our fantastic Staff. The Committee has now moved to working on developing an Employee Handbook for the staff.

Another topic rose to the forefront due to unfortunate tragedies across the country in 2018; we needed to assess our risk at St. John in terms of security. We began to explore the safety of the Preschool, as well as updating our security cameras and ability to lock down the facility. Buildings and Grounds did a great job working on the project and everyone greatly appreciates it!

Sound and Video has been worked on since 2017, with limited success in addressing audio problems. In April 2018, we asked the Sound & Video Task Force and Lifeline Audio Video to come back and requote a professional sound system. Pre-work was completed on that project and numerous informational meetings were held. We're now in the fundraising phase, looking for an installation date that would allow us to use it by Easter of this year!

Another exciting topic is a ministry sharing opportunity that St. John has entered into with Messiah Lutheran. St. John has too large of a congregation for one pastor, but we can't sustain two. The congregation had approved utilizing the services of Pastor Bauer on a part time basis to help Pastor Russ with the excess load. With the retirement of Pastor Keel at Messiah, they have been using supply pastors temporarily. In the Fall of 2018, Messiah Lutheran and St. John entered into a shared ministry contract where Messiah utilizes Pastor Bauer on a ½ time basis and he serves St. John ¼ time. Pastor Bauer is retired, so he doesn't want to work full time! This is all in preparation for Messiah calling a new pastor and the expectation is that we would continue the shared agreement. The Council is excited for what this may do in bringing these two congregations closer together!

I thank you all for the opportunity to serve as President for the past two years and Vice President for the previous two. While there were challenges, I thoroughly enjoyed it and look forward to continued service within St. John. God Bless!

2018 Finance Board Annual Report

The past few years our church has seen many changes; in 2018 we have settled into a somewhat "normal" non-changing year, although we did welcome the assistance of Pastor Norm Bauer to help ease some of the overwhelming responsibilities of Pastor Leeper, being the only pastor for a congregation our size.



We have a very dedicated group and I appreciate the time, prayer and thought that they generously give. The responsibilities of the finance board include: **a.** Develop the annual budget. **b.** Review and approve expenditures. **c.** Monitor and adjust budget expenses if necessary. **d.** Monitor and decide which investment strategies would best serve the St. John congregation.

This year has brought continued challenges to balance the expenses of our many missions, building maintenance, insurance, salaries and other expenses with the income that has come in. The 2018 year wrapped up with our total expenses being \$488,088.00 and our total income being \$459,869.00 However, our 2018 budgeted expenses were \$499,587.00, thereby under budget by \$11,499.00, so our spending is by no means excessive. Some larger expenses that we incurred in 2018 were remodeling the preschool entrances and installing a security system, striping the parking lot and repairing a storm sewer drain. In addition, the parsonage was painted.

As part of the Finance Board's responsibilities we designate where the 8% Thank Offering is given. In 2018 it was designated to the following: Meals on Wheels, "Bread of Life" store and ministry, Charles City Senior Citizens and Charles City K-9 project.

The Finance Board extends their gracious appreciation for the wonderful members of our congregation. Thank you for your support, prayers and the many gifts you share. We are privileged to serve on this board to ensure the continued growth of our St. John ministry.

Youth Board 2018 Annual Report

There was a Dartball tournament fundraiser Jan 21st that served food to about 80 people and raised \$400 towards the Houston ELCA youth gathering. Also, in January three youth, Pastor Russ, and Laurie Heidebrink registered for the Houston youth gathering. Lynne Wilkens and Rhonda Schmidtke were welcomed as new members to the youth board. Lynne was nominated as board chair and Rhonda was nominated as secretary.

It was estimated that the youth going to Houston would need approximately \$900 each to attend the gathering. A fundraiser was set up called "Envelope Please" to cover the cost. The youth going to Houston decorated the envelopes with numbers 1-120. The envelopes were all taken and more money than what was needed was received by the congregation, which then went into the middle school mission trip fund.

Easter Breakfast was moved to Palm Sunday this year to allow for families to get together on Easter Sunday. Proceeds from Palm Sunday breakfast were \$1116.50 and placed into the youth workers accounts. 192 people were served which was very similar to previous Easter breakfasts. 28 youth attended a Waterloo Black Hawks hockey game and had pizza together on April 6th. A lock in was scheduled for April 14-15 but did not have enough interest to have a team from Luther College outreach team come, so it was cancelled.

Four youth from the congregation attended WIYLDE, a youth leadership conference, which was held at Wartburg College in Waverly in June.

The middle school mission trip went to Prairie Du Chien, Wisconsin, in July and had 17 people participating, 12 being youth.

The Houston ELCA youth gathering went well despite bus problems at the very beginning. But St. John Lutheran in Nashua saved the day by having a parent with a large enough vehicle to take the students down there.

The Youth Breakfast was postponed due to congregational meeting October 7.

The Give Thanks dinner was November 11th. It went very well, and 101 people were served. This was a free meal to the congregation to give back for all their support of the youth.

The lighted Christmas parade was November 30th, the Heyers and Heidebrinks built a float to be used.

The Christmas Soup Dinner was December 9th and also had around 100 people served, this was a free will donation meal.

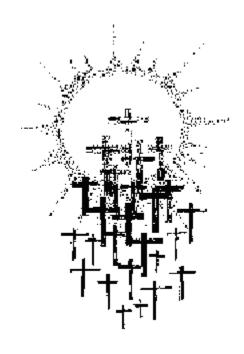
