Dear Friends in Christ,


God has blessed us richly in our 147th year as a congregation! 2019 was an exciting year of being *God's Love in Action*. I want to thank all of you who supported Christ's mission through St. John Lutheran Church and Christian Preschool last year with your time, talents, and treasures. To get the full scope of what we've accomplished together, you'll need to read ALL of the reports in this packet. I just want to highlight two areas here.

In 2019 we were God's Love in Action by...

- Coming Together in Christ-Centered Worship Every time we gather for worship Christ is present to comfort, challenge, and equip us to be His presence in the world. 2019 was no exception. Christ was present with us in worship in so many wonderful ways. It was a joy to bring back Praise in the Park this year and to have a cooling breeze on a hot and humid morning as we praised God in the heart of our community. Being able to worship together twice this year with our sisters and brothers from Messiah Lutheran was an answer to Jesus' prayer that his followers would be one (John 17:21). We were blessed again in 2019 with the musical gifts of our Trinity & Carol Choirs, Sunday School, Preschool, and a wide variety of instrumentalists. We even had a special visit from the cast of *Joseph and the Amazing Technicolor Dreamcoat!* And, of course, 2019 saw the completion of a Sound & Video Project that had been in the works since long before you called me. Youth & Family Ministries Coordinator

2019 was a very busy and active year at St. John. Below are some of the things that involved the children, youth, and families at St. John this year.

In January, the Youth Board hosted a brunch during the Annual Meeting and that started out our fundraising for the middle school and high school summer mission trip.

In February, the Youth Board organized a trip to Waterloo to watch the Black Hawks play hockey and we celebrated the Driver's License milestone with those receiving their licenses in the last year.

In March, the 5th Grade class of 13 students took First Communion on Ash Wednesday, and the Family Board sponsored a family Lent Event attended by over 60 people.

In April, The Family Board sponsored an Easter Egg Hunt attended by 37 children and their parents on Easter weekend and hosted a Ladies' Luncheon that had 83 ladies of all ages attend this fun Women of His-Story themed event. The Youth Board fed 200 people at the Palm Sunday Breakfast.

In May, we wrapped up the After-School Program, Sunday School and confirmation classes. And we celebrated with 11 St. John members who graduated from High School.

June was started with a bake sale fundraiser for the mission trip to South Dakota. I spent a good share of the month planning the mission trip, VBS, and confirmation classes for the fall. Four St. John Youth attended WIYLDE.

In July, 23 middle and high school youth and five adults took the church bus on a mission trip to the Black Hills of South Dakota from the 8th-13th. We had a lot of fun, and accomplished a lot of work, despite some hot weather and a little bus trouble on the way home. I feel so blessed to be a part of a group of people who continually make the best out of the situation even when it keeps changing!

August started out with VBS and 70 youngsters attending "ROAR" VBS where we learned that even though "Life is Wild, God is Good!" The Parish Education Board did a fantastic job of organizing, decorating and hosting VBS again this year! The Youth Group hosted a food booth at the Encouragement Corps Concert just as school started up.

In September, we kicked off the school-year schedule with Rally Sunday. During worship we celebrated the Blessing of the Backpacks Milestone, and the participants of the mission trip gave a presentation about the trip. Afterwards, the Family Board made a delicious meal, and Parish Ed hosted some fun games in the parking lot. We held the First Step Milestone for three-year-olds entering Sunday School, and the Entering Confirmation Milestone for 7th Graders entering our Confirmation program. We started up our confirmation program and Sunday School and Family Board held a Children's Clothing Swap. What a month!

In October, we started up the After School program and we held our "Confirmation Fair" and invited the congregation to come and view the "Faith Tri-Folds" each of our confirmands created, and then we celebrated Affirmation of Baptism with ten students who completed the St. John Confirmation Program. Later in the month, the St. John bus took our confirmation students to Waterloo to participate in a Feed My Starving Children Mobile Pack event. We handed out Bibles to 1st and 4th Grade students on Reformation Sunday.

November is Food Month for St. John Sunday School students. Sixty-five non-perishable food items were collected and donated to the food pantry!

In December, the Family Board hosted a 25 Cent Gift Store for kids to shop and it was a great success again this year with 1200-1300 gifts being purchased! And on a chilly evening, some St. John members rode on, and walked alongside, the parade float. The Parish Ed Board coordinated and directed a really nice Sunday School Christmas Program with our PreK-6th grade students reciting some memory verses and acting out the story of Christ's birth. The Youth Board hosted a Soup Dinner that fed 100 people following the Program.

The Youth, Family, and Parish Education Boards and the children, youth and families of St. John had a great year in 2019. And I would like to thank everyone who contributed to the success of, and participated in, all these wonderful activities. We look forward to another fantastic year in 2020.

St. John Christian Preschool 2019 Annual Report



Praise God from whom all blessings flow! It is a privilege to be part of the development of not only our little ones' academic and social skills, but also their spiritual growth. It is so exciting to see their eyes light up when they listen to God's word or to see a smile stretch upon their faces when they are singing and dancing to our praise music. We continue to receive blessing upon blessing to enrich and grow our preschool center!

Our 2018-2019 school year ended with an enrollment of 45 friends and we were excited to welcome many friends and families back for our 2019-2020 school year. With the addition of a few new faces we were able to start our school year with an enrollment of 42 friends who were anxious to see what a new year at St. John Christian Preschool would hold for them. Fortunately, due to some families moving into the area, we gained a couple friends during the second semester. As we begin 2020, we will see an enrollment of 44 little ones. As always, we know that we will continue to be blessed with many families who are seeking a Christian education for their little ones and we expect to fill any openings quickly. It is a very humbling gift to know that we are being trusted with such an enormous job, but it is rewarding beyond words.

We continued to offer four classes from which our families could choose. Our older friends who turned at least 4 by September 15 could enroll in either the three-day, Monday-Wednesday-Friday program or the 5-Day program. These classes were only offered in the afternoon, which met from 12:30-3:30pm. Our younger friends who turned at least 3 by September 15 could enroll in our two-day program, Tuesday-Thursday, or our three-day program, Monday-Wednesday-Friday. These classes were only offered in the morning, which met from 8:30-11:30 a.m.

Our registration fee remained the same at \$25 per semester or a one-time fee of \$40 for the year. Our two-day tuition remained the same at \$80 and the three-day tuition was \$95. Both 3-Year-Old class options are three hours. Our 3-day afternoon tuition remained the same at \$95 and the 5-Day tuition was \$170. Our preschool board offered a tuition reduction fundraiser each semester, which provided opportunities for families who participated in the fundraiser to earn profits to lower their child's tuition payments. Each semester about 20 families participated and their tuition accounts were reduced accordingly.

We continued to be blessed with grant money from Floyd-Mitchell-Chickasaw Early Childhood Iowa (ECI) scholarship program, which is an amazing form of assistance for almost half of our preschool families. ECI scholarships are available for families displaying a financial need for help with tuition.

This year we were able to offer 2 scholarships in Cindy Zirbel's memory. Cindy and her husband, Jim, believed in and set a high priority on the Christian preschool experience for their own children. This scholarship was awarded to a family with the same priority. These scholarships were not based on financial need, but rather awarded to families who wrote a short letter explaining why they chose SJCP. Families enrolled in our 4/5-year-old programs that were not eligible for ECI funds were encouraged to apply. The scholarships were offered to two families. Each scholarship was in the amount of \$50 a month for each of the eight months in the school year. This year, we had three families apply, but one family was already pre-qualified for ECI. The two families selected were very appreciative recipients and we were pleased to be able to offer this scholarship to these well-deserving families.

We also have the "Friendship Scholarship" for our younger, 3/4-year-old programs. Families enrolled in these programs that were not eligible for ECI funds were encouraged to apply. This scholarship was awarded to families who hope to not only establish a strong educational foundation for their little one, but also hope to raise their child to be a kind and gentle friend who will one day give back to his or her community. They applied for this scholarship by writing a short letter explaining how they thought their child's preschool experience would impact the person they later become. Two scholarships were offered in the amount of \$45 a month for each of the eight months. This year, we had four families apply. The two families were very appreciative recipients and we were pleased to be able to offer this scholarship to these well-deserving families.

The Preschool staff and board members would like to remind everyone that Kwik Star gift cards are always available for purchase at the Preschool. Since you need to purchase gas anyway, why not help out our ministry all at the same time? Feel free to stop by and purchase at your own convenience. Please stop by or call the preschool at 228-7274 if you are interested in purchasing a gift card. Let us know if you have any questions, and as always, thank you for your support!

We are very blessed with an amazingly awesome staff: Whittney Franke, Director and Carleen Laue, Assistant Teacher/Onsite Supervisor. We are also supported by an amazing back-up team that includes our Foster Grandmas, Evelyn Schmidt and Cindy Kearney; as well as our dedicated Pastor Russ Leeper; faithful office secretary, Kathy Hoeft; highly efficient business manager, Linda Hughes; and a great custodial staff, Jamie Carolan and Julie Heddens. Without their hard work, we would not be able to accomplish the things that we do.

Our energy is contagious, and our hearts are big. The preschool is always a busy place and you can be sure to see smiling faces if you walk past our doors. We know that there are many reasons for the happiness that abounds from our center, but we also know that the biggest reason is that this is a place where our little ones can experience God's love "hands on." Through our praise music, our Bible stories, our interactions with tall and small friends, God's love is growing here, and it is one thing that our preschoolers won't be able to outgrow anytime soon.

The St John Church Council donated 'Benevolence Funds' to the following organizations during 2019: North East Iowa Food Bank, Alzheimer's Support Group, Parkinson's Support Group, Local Food Bank, Lutheran Disaster Relief, St. John Vacation Bible School (registrations), Relay for Life, National Child Safety Council, Friends of Cancer, Sam Sindlinger for Mexican Mission Work, The Student Homeless Housing Program in the CCCSD, 'Be The Match' – Bone Marrow Registry, and the purchase of a wheel chair for a person in need. Think about it; these donations are truly "God's Love in Action".

The Sound & Video Capital Fund Drive began in earnest in January and by April we had raised more than enough, (through direct payments and pledges – approximately \$135,736.00), to pay for the entire project. Thank you to Jeremy Heyer for his leadership and guidance in seeing this project through to its completion. Again, God's Love in Action.

Retirement of long-term employee, John Swiggum, occurred at the end of June 2019. At the end of June, we were fortunate enough to hire Jamie Carolan as his replacement as Head Custodian. God's Love in Action.

The Finance Board requested an internal audit, which was led by congregational members. Conducted during the last week of June 2019, the audit found no major problems, but there are some recommendations for the Finance Committee and Business Manager to follow up on. God's Love in Action.

Pastor Leeper, Kurt Hoeft and Laurie Heidebrink attended the N.E. Iowa Synod Assembly June 14, 15 and 16, 2019 in Waverly, IA. God's Love in Action.

With a spark from the Communications Board, an All-A-Board Meeting night was planned for, and eventually held, in August 2019. All boards met in the Parish Hall at the same time, then gave a brief report on their activities and plans. It was so successful a second All-A-Board meeting night was held in November 2019. These have proven to be very effective and very well received. All-A-Board meeting nights (God's Love in Action) are planned for every three months for the foreseeable future.

Led by Janet Petefish, a stained-glass ministry came into being. (God's Love in Action). Using salvaged sections of the original Ascension stained glass window at St. John Lutheran Church, these pieces were restored into a work of art by Eddie Haselroad of Greene, IA. The large, back-lit, stained glass window in the Narthex is the culmination of over a year's planning and building by Greg Heidebrink (built frame and installed window) along other local contractors. Numerous smaller pieces, from original stained-glass windows, were hand-made by members of the congregation and sold as mementos and memories.

In September, the Stewardship Board brought to the Church Council, plans for a Consecration Sunday Stewardship Program. On November 10th, 2019, St. John Lutheran Church held its Consecration Sunday event. On this Sunday, the goal was to give the congregation an opportunity to complete an Estimate of Giving Card, emphasizing the idea that stewardship is part of our worship of God, rather than a fundraising procedure. St. John's annual church budget will be developed from the giving cards. The response from our church membership was outstanding and our annual giving is forecasted to increase by nearly twenty four percent. Again, God's Love in Action.

There is a movement within the church to conduct a training on "Safe-Guarding God's Children". Our goal is to hold this training in the fall of 2020, inviting other churches to participate as well. God's Love in Action.

Employee Job Descriptions were updated, and an Employee Handbook was created over the past two years, by the Personnel Committee, to bring St. John Lutheran Church in line with current employment practices and laws. This Employee Handbook went into effect January 1, 2020. God's Love in Action!

Thank you to every member of the St. John staff, the Pastors and our truly diverse congregation, for allowing me to opportunity to witness "God's Love in Action". Sincerely,

2019 Finance Board Annual Report

This year, as in past years, has brought continued challenges to balance the expenses of our many missions, building maintenance, insurance, salaries and other expenses with the income that has come in. The 2019 year wrapped up with our total expenses being \$512,416.94 and our total income being \$459,028.63. However, our 2019 budgeted expenses were \$513,077.33, thereby under budget by \$660.39, so our spending has not been excessive but necessary.



Some of the larger expenses that our church as incurred in 2019 were tuckpointing the bell tower and the chimney, parking lot repair, installation of our new sound and video system, and the remodeling the parsonage bathroom. Currently \$23,148 in pledges for the sound and video system are yet to be fulfilled due to two-year commitments to this mission.

Part of the Finance Board's responsibilities is designation of the 8% Thank Offering. In 2019, this money was given to: "Retrieving Freedom" companion dog, Floyd County Fair Board for replacement of contents lost in the May tornado, Washington School playground project, Floyd County Salvation Army Red Kettle Fund, Charles City Police gift fund, the Charles City Chamber of Commerce "Holiday Cheer Fund", Floyd County Friends of Cancer, and Coats for Kids.

Our Board is thankful for Stewardship Board's efforts in organizing Consecration Sunday with the hope of increasing giving in the coming year. With that in mind members of the Finance Board have worked very hard in preparing a balanced budget for 2020 and, with our Congregation's generous and continued support, this should be manageable.

The Finance Board extends their gracious appreciation for the wonderful members of our congregation. Thank you for your support, prayers and the many gifts you share. We are privileged to serve on this Board to insure the continued growth of St. John's ministry.

- ✓ Sept. Curbside shrubbery removed, and area seeded down because of lack of maintenance and poor aesthetics. Tuck pointing done on exterior brick. Greg Heidebrink installed stained glass Ascension window in narthex.
- ✓ Oct. Nov. Concrete work in parking lot done on worst parts this year with more be done next. Emergency Shelter/Evacuation Plan discussed and meeting with Floyd County Emergency Management Coordinator (Lezlie Weber) and Charles City Fire Chief (Eric Whipple). Locations within the church were identified to be used in case of emergencies; a template for procedures to be followed was acquired and is in the process of being made applicable to St. John. Parsonage dishwasher was leaking water again, so was replaced. Moved pew for Church ADA Compliance to allow a wheelchair use in Sanctuary. Tuck pointing seems to have stopped later leak around bell tower.
- ✓ Still working on TV in narthex (ushers can't see new screen during service), a new information center, what to do about the bus.

2019 Family Board Notes

The family board had a successful 2019.

ANGEL TREE In December 2019, the Angel Tree Ministry collected and distributed 42 gifts to 17 children of prisoners and their caregivers. Each child received two gifts and their caregiver received one gift. In addition to the donated gifts, each family received a variety of Bibles or other religious materials which were provided through cash donations from the St. John congregation. Bibles and Christmas cards were sent to 9 prisoners. Six local families received Hy-Vee food vouchers which were provided by Angel Tree donations. 
