She also participated in drive through communion this last Sunday and gave the blessing to attendees. January 3, 2021 will be her first sermon. Pastor also reminded the council how church this Christmas season will look very different than previous. He has been working on numerous videos to present with different age groups all through video. He has continued to preside at numerous baptisms.

### **OLD BUSINESS:**

**Board Reports:** Building and Grounds had no report, Communication board has filled their open positions for the coming year. Deacons have shortened the drive through communion time by 30 minutes. There will be drive through communion from 3:30-5:00 PM on Christmas Eve. Family Board has distributed Advent calendars to kids, they will also be starting a thread through Facebook for Christmas cards to be shared. No reports for Parish Ed., Stewardship or Youth. Finance had approved the bills for the month to be paid and will present the 2021 ministry support plan later in the meeting. Also noted that the staff have decorated the church for the holiday season to be more festive with the video recordings that are being broadcast weekly.

## **Financial Report:**

Linda Hughes gave a report on the financials for November, the church continues to stay close to the budget for the year. It was also mentioned it would be helpful if more of the congregation would participate in the Simply Giving to have a consistent offering. Kathy Waldorf made a motion to approve the November Financials, Carol Brahn second the motion. Motion carries.

#### **Monthly Benevolence:**

Janet Petefish has made 25 quilts for the patients at the hospital for the holiday season. Currently another community group is gathering donations to be given to all the residents of the local care facilities. Ron James made a motion to reimburse Janet Petefish \$205.00 for expenses for the quilts. Dennis Sande second the motion. Motion carries. They will be distributed to the hospital, and Janet will also contact the Charles City Press to see if they could take a picture and possibly include an article in the newspaper showing the church's theme "God's Love in Action". Janet made a motion to send the remaining balance to the Food Pantry. Ron James second the motion. Motion carries.

## **2021 Ministry Support Plan Approval**

Kurt Hoeft from the Finance Board reviewed the 2021 Ministry Support Plan with the council. Most boards held their expenditures at the same level as the previous year or decreased. Building & Grounds did increase a couple expenditures to include repair on the Air Conditioning in the office and work area as well as the parsonage will be needing a new roof. Also increased funding for Epic grants as per stipulation from the bequest we are only allowed to use the interest which does not cover the funds being distributed. A pay raise for the staff was included to cover the 1.3% cost of living expense. As a cost saving measure the church secretary will no longer order bulletins but will instead design a cover for bulletins at a substantial cost saving to the church. Discussion was given to the budget for the Preschool. In years past the church Council has not been active in that budget but with a substantial shortfall the last few years a committee will meet with Whittney Franke the Preschool Director to determine how to best proceed to balance that budget. Ron James made a motion to approve only the Church 2021 Ministry Support Plan, Kathy Waldorf second the motion. Motion Carries.

### **Nominating committee 2021:**

The nominating committee reported that most of the council and board positions have been filled but they will continue to contact parishioners to fill the remaining openings.

President Greg Buenger will contact the synod office to visit with them and their recommendations for the church annual meeting. At this time, we will plan to postpone the meeting to a later date due to the Covid-19.
